

# Privacy Notice for Ali Reza Sinai.

Thank you for choosing to instruct me in your case. I will need to collect and hold your personal information in order to represent you. I will take all possible steps to protect your personal information. I am determined to do nothing that would infringe your rights or undermine your trust. This Privacy Notice describes the information I collect about you, how it is used and shared, and your rights regarding it.

## **Data Controller**

I am registered with the Information Commissioner's Office (ICO) as a Data Controller for the personal data that I hold and process as a barrister. My registered address is Selborne Chambers, 10 Essex Street, London WC2R 3AA and my registration number is Z9060263.

## **Data Collection**

All of the information that I hold about you is provided to or gathered in the course of your case and/or proceedings. Your solicitor and/or I will tell you why we need the information and how we will use it.



# The Lawful Basis for processing your information

The General Data Protection Regulation (GDPR) requires all organisations that process personal data to have a Lawful Basis for doing so. The Lawful Bases identified in the GDPR and which apply as between us are:

- The data subject has consented to the processing;
- The processing is necessary;
- In relation to a contract which the data subject has entered into;
- Because the data subject has asked for something to be done so they can enter into a contract;
- Performance of a task carried out in the public interest or in the exercise of official authority vested in the controller; or
- The legitimate interests of ourselves, or a third party, except where such interests are overridden by the interests, rights or freedoms of the data subject.

## I use your information to:

- Provide legal advice and representation;
- Assist in training pupils and mini-pupils;
- Investigate and address your concerns;
- Communicate with you about news, updates and events;
- Investigate or address legal proceedings relating to your use of my services/products, or as otherwise allowed by applicable law;

I do not use automated decision-making in the processing of your personal data.



I collect and process both personal data and special categories of personal data as defined in the GDPR. This includes:

## Client data

- Name;
- Email;
- Phone number;
- Address;
- (on occasions) Payment or bank details;
- Date of birth;
- Location details;
- Device IP address:
- Financial information

# I may share your personal data with:

- Instructing solicitors
- A Pupil or mini pupil, under my training
- Opposing Counsel, for the purposes of resolving the case
- My Chambers management and staff who provide administrative services
- My regulator or legal advisors in the event of a dispute or other legal matter;
- Law enforcement officials, government authorities, or other third parties to meet our legal obligations;
- Any other party where I ask you and you consent to the sharing.



# Transfers to third countries and international organisations

It may sometimes be necessary to transfer personal information overseas. Where I do so, it will be to a country within the EEA or which is recognised as having comparable protection to that afforded to countries within the EEA and which are subject to the GDPR.

I retain your personal data while you remain a client and subject to my Retention and Disposal Policy (copy available on request). This document details how long I hold data for and how I dispose of it when it no longer needs to be held. I will delete or anonymise your information at your request unless:

- There is an unresolved issue, such as claim or dispute;
- I am legally required to; or
- There are overriding legitimate business interests, including but not limited to fraud prevention and protecting customers' safety and security.



# **Your Rights**

The General Data Protection Regulation gives you specific rights around your personal data. For example, you have to be informed about the information I hold and what I use it for, you can ask for a copy of the personal information I hold about you, you can ask us to correct any inaccuracies with the personal data I hold, you can ask us to stop sending you direct mail, or emails, or in some circumstances ask us to stop processing your details. Finally, if I do something irregular or improper with your personal data you can seek compensation for any distress you are caused or loss you have incurred.
